
OREGON DISTRICT ATTORNEYS

There shall be elected by districts comprised of one or more counties a sufficient number of prosecuting Attorneys, who shall be the law officers of the State, and the counties within their respective districts, and shall perform such duties pertaining to the administration of Law, and general police as the Legislative Assembly may direct. Article VII § 17 of the **Oregon Constitution.**

JUSTICE FOR ALL: Aspirational or Achievable?

<u>Declaration of Independence</u>: "All (people) are created equal, endowed with certain inalienable rights: Life, Liberty, and the Pursuit of Happiness..."

<u>US Constitution</u>: "...in Order to form a more perfect Union, **establish Justice** (emphasis added), insure domestic Tranquility, provide for the common defence and secure the Blessings of Liberty..."

<u>Pledge of Allegiance to the Flag</u>: "...liberty and justice of all."

Georgia Constitution: "To perpetuate the principles of free government, insure justice to all (emphasis added), preserve peace..."

ETHICAL & LEGAL RESPONSIBILITY

State v. Florida, Fl Dist Ct App 4th District (2003)

It is essential that lawyers educate themselves as to the availability, requirements, and appropriateness of drug court programs... It is equally important for the institutions that educate future lawyers, as well as those that educate the other disciplines that play vital roles in the drug court process to incorporate drug courts into their curricula.

For lawyers to do otherwise is for them to become legal dinosaurs. To ignore the need to learn about the drug court process is to ignore the evolution of the justice system (emphasis added). The sooner the Bar educates itself, the sooner the issue raised in this case will become extinct.

PROSECUTOR'S ROLE IN CENSUS EXPANSION

Prosecutor as Gatekeeper

Why: The Prosecuting Attorney is responsible and accountable to the community for public safety and justice.

How: Through informed decisions relying upon evidence-based best practice standards.

INTERNAL STRATEGIES

- 1. Assess eligibility criteria for HR/HN participants.
- 2. Assess eligibility criteria for "Drug Driven Crime."
- 3. Assess eligibility criteria for person crimes.
- 4. Assess eligibility criteria for DCS by drug users.
- 5. Conduct a comprehensive assessment of DTC process for demographic disparities.
- 6. If disparities exist, execute strategic adjustments in process to improve inclusivity.
- 7. Assess eligibility criteria for misdemeanors.



EXTERNAL STRATEGIES

- 1. Build trust-based relationships with underrepresented communities.
- 2. Promote collaborative relationships with the defense bar, and support defense funding.
- 3. Advocate for legislative support of treatment funding.
- 4. Advocate for funding support for infrastructure.
- 5. Promote community awareness.
- 6. Strategize based on demographic data study.
