Forensic Peer Mentor Training Project

In 2015 the Georgia Mental Health Consumer Network (GMHCN) partnered with Department of Behavioral Health and Developmental Disabilities (DBHDD) to establish the Forensic Peer Mentor (FPM) Project.



FPMs serve returning citizens who have behavioral health and/or substance use diagnoses by using the mentor's most valuable tool, her/his personal lived experience.

GMHCN developed the Peer Mentoring Project Pilot Program from the Olmstead decision and contracted with the DBHDD to better serve individuals with behavioral health diagnoses






FPM Overview

Some of tasks include, but are not limited to:


- ✓ Serve as a role model




