IMPORTANT REMINDER

LS/CMI ASSESSMENT TRAINING DEADLINE IS APPROACHING

As a friendly reminder, effective October 1, 2019, the Level of Service Inventory - Revised (LSI-R) will no longer be provided by the Council of Accountability Court Judges (CACJ). The Level of Service Case Management Inventory (LS/CMI) will replace the LSI-R.

The deadline for LS/CMI user training completion is August 31, 2019.

Please note after completion of the online training, the LS/CMI users' training certificate of completion must be submitted to the CACJ website.

After CACJ has received the user's training certificate of completion, details for the mandatory webinar will be emailed to the user.

Courts will not receive LS/CMI uses until the online training and mandatory webinar have been completed.
