NORTHEASTERN JUDICIAL CIRCUIT CELEBRATES MILESTONE ANNIVERSARIES FOR HALL & DAWSON COUNTIES





The Northeastern Judicial Circuit celebrated milestone anniversaries for several of their accountability court programs on July 2, 2021. Hall County Drug Court, the Circuit's first accountability court, marked 20 years in operation while Dawson County Treatment Court and Hall County Family Treatment Court celebrated 15 years and Hall County Parental Accountability Court celebrated 10 years. The joint celebration event brought together founding and current team members, program graduates, and community partners. Senator Butch Miller opened the ceremony by presenting the courts with official proclamations outlining numerous accomplishments over the past two decades. Senior Judge John Girardeau, who founded Hall County Drug Court in 2001, reflected on the progressive approach to criminal justice reform and treatment that the Circuit has prescribed to since the initial vision to start the programs 20 years ago. Senior Judge Cliff Jolliff, who first presided over Hall County Family Treatment Court, also spoke about the groundbreaking work of these programs and the immense effect they have on the community. Current presiding judges of the Circuit's programs, Honorable Kathlene F. Gosselin, Honorable Bonnie C. Oliver, Honorable Jason J. Deal, Honorable Clint G.



Bearden, and Honorable Alison W. Toller, also spoke during the ceremony and shared their passion for this work. Guests at the event viewed a short promotional video outlining the origins of the programs, the many successes including a significant economic impact to local taxpayers of approximately \$55 million, and testimonials from program graduates.

"The mission of our programs is to disrupt the cycle of criminal offenses whose origins are rooted in substance use or mental health issues," said Jessi Emmett, Treatment Services Director. "We strive to assist individuals in solving these issues and building productive and fulfilling lives while maintaining personal responsibility and providing a cost-savings to our local communities. From the judges, attorneys, and law enforcement to the treatment staff, it is as honor to work alongside some of the greatest professionals in our fields who all share a passion for making a positive difference."

These programs, along with the H.E.L.P. Programs and DUI Court, collectively serve between 450-500 participants and fall under the umbrella agency, Treatment Services. Each program offers individual and group therapy, continuous drug testing and judicial oversight with the goal of bringing about a behavioral change that reduces criminal recidivism and provide the tools and resources necessary to address substance abuse and mental health issues. The accountability courts of the Northeastern Judicial Circuit continue to lead the state and serve as role models to other accountability court programs.

TROUP COUNTY DUI/DRUG COURT

On July 22, 2021, Troup County DUI/Drug Court participants were treated to a very special presentation from Auburn University's Southeastern Raptor Center. The Southeastern Raptor Center is a regional rehabilitation and education facility which provides educational programming for those interested in learning about raptors and care to birds of prey in need. Three trainers, led by Assistant Director Andrew Hopkins, delivered a Birds of Prey lecture and demonstration featuring the Screech Owl, Red Tail Hawk, and Golden Eagle. The Golden Eagle, Aurea (Latin for Golden), is considered War Eagle VIII. She made her stadium debut at Auburn University in 2018 before becoming the main War Eagle in 2019. With a 6 ½ foot wingspan and the ability to take down a mountain goat, she is a very impressive bird.

The Raptor Center presentation was arranged by Judge Wesley Leonard in celebration of the DUI/Drug Court's summer Bird Watching project. This project, designed and spearheaded by Case Manager Debra Trapp, provided program participants with a bird watching field guide, educational materials, and a log for documenting identified birds. The rationale behind the project is to encourage a healthy, pro-social summertime activity. This project also serves as a contest to see who can earn the most points (each bird has a designated point value). There is a cash prize that will be awarded to the participant with the most points at our first DUI/Drug Court Status Hearing in September.

A special thanks to Judge Leonard, Ms. Debi, our 501(c)3, Accountability Troup, and the Southeastern Raptor Center for this riveting and educational event. It was tremendously enjoyed by all!

FULTON COUNTY JUVENILE COURT

Juvenile Drug Court Program - CHOICES (Choosing Healthy Options Increases Confidence, Excellence and Success) celebrated its most recent program graduate on June 22, 2021. Semaj entered the CHOICES program in November 2019. He had struggles with being a juvenile offender, years of challenges in school, and challenges with substance abuse. Since entering the CHOICES program, Semaj has not received any additional criminal charges, is enrolled in a GED program at Atlanta Area Technical College and has made significant progress with his substance abuse issues.





The Family Treatment Court Program – HOPE (Helping Our Parents Excel) celebrated its most recent program graduate on June 16, 2021. Natalie entered the FTC program on May 15, 2019. Although extremely shy, Natalie was always open and honest about her substance use history. After receiving evidenced-based treatment, she became more insightful regarding how to break the cycles of addiction, began using coping skills, and eventually became a mentor to other program participants. At the time of graduation, Natalie had regained custody of her children, obtained stable employment, and secured permanent housing.

CACJ PROMOTIONS AND STAFFING UPDATES

As of June 1, 2021, **Kimberly Howard** is now serving as the Operations and Training Manager, and **Rachel Gage** is serving as the Data Programs Manager and Certification Officer II. Effective August 1, 2021, **Tara Zellous** began a new role with the Council, as she will now serve as the Treatment Services Program Manager.



Ms. Kimberly Howard joined the Council of Accountability Judges in 2017. Prior to joining the Council of Accountability Court Judges, she held the position of Pretrial Release Officer II with the Fulton County Superior Court Pretrial Services Division from 2012-2016 and served in the private sector as a Field Services Manager for nine years. She is a graduate of Albany State University and Michigan State University and holds a Master of Science Degree in Judicial Administration. Ms. Howard, an advocate of continuing education, recently completed the National Center for State Courts' Institute of Court Management (ICM) professional development Certified Court Manager (CCM) program. She also is a member of the Georgia Council of Court Administrators and National Association of Court Management.

She is a licensed professional counselor (LPC), a national certified counselor (NCC), a certified professional counselor supervisor (CPCS), and a certified alcohol and drug counselor-II (CADC-II). Her clinical experience includes work in lead counselor roles at both McIntosh Trail and Advantage Behavioral Health Systems Community Service Boards and as clinical assessor at Dekalb Medical Center and Ridgeview Institute.

Ms. Zellous gained accountability court experience while providing direct treatment as an accountability court liaison for participants in the Ocmulgee Judicial Circuit substance abuse and mental health courts. She then transitioned to the Georgia Department of Behavioral Health and

Developmental Disabilities (DBHDD) where she worked to build collaborations among accountability courts and community service boards. Prior to becoming Treatment Services Manager at the Council of Accountability Courts Judges, Ms. Zellous served the Council as Treatment Fidelity Program Monitor and then as Statewide Medication Assisted Treatment Coordinator.

Research Grants Available from the Justice Community Opioid Innovation Network

The Justice Community Opioid Innovation Network (JCOIN) <u>Rapid Innovation</u> <u>Grant (J-RIG) program</u> is a rapid funding mechanism to support small research grants to study newly emerging policies, practices, or interventions that address prevention and treatment of addiction among justice-involved populations.

J-RIG welcomes both applicants who work in research environments and those who do not work in research environments but could benefit from funding to study local initiatives, policy changes, or practice improvement efforts. J-RIG projects also are appropriate for developmental pilots, feasibility studies, or other research broadly defined as foundational work for further research and practice.

The J-RIG call for proposals will be released up to three (3) times per year. Funding will be provided for up to 24 months and may not exceed \$110,000 in total costs.

Interested applicants will need to register for a free JCOIN account to view the <u>funding opportunity</u> and <u>request for proposals</u>. Don't wait! Applications are due by August 16, 2021.
