Position Title: Misdemeanor Mental Health Court Case Manager – Full-time/Exempt

Position Summary:

- Explains MMHC in detail to potential participants, community stakeholders and others.
- Researches and identifies new treatment providers within the community.
- Assists in ensuring the accuracy and follow through of federal, state and local grant requirements.
- Maintains procedures for confidentiality and release of criminal history information, and adherence to and compliance with established Federal, State and local standards and guidelines.
- Serves as liaison between the Judge, other staff, other departments, courts, attorneys, family members and the public to ensure efficiency for the MMHC.
- Assists with compiling, analyzing, monitoring and evaluating data to show the effectiveness of the MMHC and outcomes based on identified performance goals.
- Manages a majority caseload of MMHC participants, maintains case files, and enters data into the case management system.
- Works independently, if needed, and capable of multitasking with efficiency and accuracy in fast-paced and sometimes stressful environment.
- Works collaboratively with the MMHC judge(s), coordinator, clinical director to promote and sustain court policy, procedure, protocols, etc. to include newsletter graduate and other contributions.
- Assures continuity of care for all MMHC participants to include connecting participants to intensive services i.e., residential and inpatient treatment as needed.
- Evaluates information and makes decisions and other recommendations within established policies and procedures.
- Attends and participates in weekly court session and interdisciplinary team meeting sessions as well as all required training and community involvement and engagements.

Preferred Requirements: Bachelor's degree in Criminal Justice, Social Work, Psychology, Public Administration, Sociology or related field preferred; LCSW, MSW or LPC a plus; three to five years of experience working in the criminal justice system, social work, Accountability or Treatment Court or related field. Direct knowledge and experience working with a mental health court model is preferred.
