Rodney served in the United States Army. During his five years in the service, he was an Automated Logistical Specialist. He completed VTC successfully and was

affectionately known as "Mr. Consistency". As his graduation Community Service Project, Rodney partnered with the American Legion in Clayton County to complete a paint restoration on the outside of the facility. He was able to get all materials donated from Home

Depot. A lot of time and sweat went into this project, and he did a wonderful job.

William served in the United States Navy for six years as Electronic Tech Supervisor. He initially struggled but, with great determination, completed the program without hesitation. He was also successfully able to create his very

own non-profit organization "M.O.R.E. (Military Operation Restoration Experience)," while in the program. William partnered with the Paula Crane Center in Clayton County to complete his Community Service Project. The Crane Center is designed and

### MODEL COURTS FEATURE

The goal of Georgia's Accountability Court Model Court program is to recognize the great work of accountability courts across the state, as well as identify strong programs that may serve as mentors for other courts. Programs identified as Model Courts are those that have met and exceeded adherence to Georgia's Standards as dictated by strong performance on certification and peer review processes. To recognize the talent and expertise of the accountability court community, each month CACJ will recognize a model court or two and their work in the substance use and mental health fields.

# Barrow County Drug Court

Court type: Drug Court

Presiding judge: Judge Currie Mingledorff, II has presided over the court since program inception in 2010.

Coordinator: Victoria Bowman is the Director.

Inception date: 2010

Number of graduates to date: 93

Current program census: 30

Recidivism rate: Graduates after 24 months: 13%; Graduates after 36 months: 16%

**Innovative practices/unique programming:** "The Alumni implemented a kickball game as a sober activity for our participants! Lots of fun and we allow it to count as a community support meeting for active clients (recovery networking)!"

"Our Phase V participants must complete a Give Back Project before graduation. It is a 40-hour community service project that they must complete in the community. They design it, plan it, execute it, and then provide a report to the Court and Team! It has been very successful, and the participants really find it purposeful and enjoyable!"

### Why do you choose to preside over the accountability court?

Judge Mingledorff: "Several years ago, while I was still practicing law, a client came seeking to legitimate his three-year-old daughter. This client was the picture of maturity and stability. He was in his mid-to-late 20s, working full-time, taking classes at a local college, and stepping up to become more of a real dad to his little girl. But I was nearly blown away when he told me that just a few years before he had been hooked on meth and had even sold some to support his habit! He then added that the best thing to ever happen to him was getting arrested and sentenced to the Hall County Drug Court. I was sold on accountability courts from that moment! A few years later, when I became a judge, I jumped at the chance to preside over the creation of our circuit's first drug court. A short time later, due of the powerful example and influence of the late, great Judge Steve Goss, I presided over the creation of our circuit's first Mental Health Court. Presiding over these courts has been the most professionally rewarding thing I have ever done!"

#### What do you hope to accomplish as a model court?

Judge Mingledorff: "As a Model Court, we continually strive to follow best practices in the hope that we will be instrumental in bringing the blessings of recovery and wellness to many more participants. We know this has a ripple effect into their families, especially their children. Just as addiction and mental illness runs in families with devastating consequences, recovery can also run in families with positive impacts over generations. These courts have a lot of moving parts. We have made plenty of mistakes of our own along the way. We are grateful for the opportunity to help our sister courts work though some of the challenges we have already experienced."

**Ms. Bowman**: "Provide encouragement and support to at least one other program! It is a hard job, but necessary, and encouragement and support can go a long way! I also hope to learn from other programs as to how we can improve our services!"

#### What are you most proud of in terms of the program's success?

**Ms. Bowman**: "I am proud of our AWESOME team!!! We have team members who care and work together to serve the participants and community! Everyone does their part, and the program works because of such! We are serious about our program reflecting best practice standards and current research! We are willing to modify our policies and practices to accommodate them because we believe they assist us in serving our clients and community better. I am also proud of the partnership with The Treehouse! We have

been able to provide our high-risk parents with free parenting classes and resources! Our parents have been able to retain custody of their children and become better parents because of this added support! I am proud of the partnership with the Barrow County Adult Literacy program! They provide GED classes and scholarships for GED tests! We have had five participants obtain their GED while in the program, and it has been such a wonderful boost of confidence for them! I am also proud of the cost savings we're able to provide our community! The Barrow County Drug Court has been able to provide an estimated cost-savings of \$1,524,885 because of alternative sentencing to prison and \$616,025 because of less jail time in local jails."

### What is something you wish you had known at program inception that you hope to impart to newer courts?

Judge Mingledorff: "I wish I had understood sooner my own critical leadership role in the court, as the presiding judge. The early going was made tougher for our whole team because it took me a while to fully commit to paying the price in the form of studying and taking advantage of training opportunities. These courts work, but we are far more likely to have success if we are faithful to the model and committed to keeping current with best practices."

**Ms. Bowman**: "There is a steep learning curve when it comes to these programs! I believe it takes at least a year to become familiar with the program operations. So, new coordinators, be patient with yourself! SELF-CARE IS A HUGE MUST!! Because we're doing important work, we tend to overwork ourselves. And other days, the workload seems endless. TAKE CARE OF YOURSELVES! Take the necessary time to disconnect and unplug to replenish!

#### Words of Advice...

**Ms. Bowman**: "Do not hesitate to copy and 'steal' every good idea, form, policy, or practice you can from courts that function at a high level. We certainly have! Be willing to share your own good ideas, successes, and hard lessons learned."

### What are you most proud of in terms of the program's success?

**Ms. Bowman**: "I am proud of our partnership with Reboot Jackson, our local recovery community outreach center! They have sat on our staffing team for the last two years and have greatly improved our program and clients' retention rate in recovery services during the program and after program completion! They add a much-needed perspective at the staffing table that we had been missing! Reboot Jackson earned the award for the 2021 Recovery Community Outreach program of the year! And Sunshine McCoy was named the 2021 CARES/Peer Support Specialist of the Year! VERY PROUD OF REBOOT JACKSON TEAM MEMBERS!!!

Additionally, I am proud of the cost savings we're able to provide our community! The Piedmont Circuit Mental Health Court has been able to provide an estimated cost-savings of \$673,643 because of alternative sentencing to prison and \$268,390 because of less jail time in local jails."
