RE: FY2026 Data Collection Updates

DATE: June 3, 2025

The purpose of this memo is to summarize data collection changes and updates for Fiscal Year 2026. The proposed data changes are meant to refine areas of data collection to improve the quantity and quality of data received by the Council of Accountability Court Judges (CACJ) for all state funded accountability courts. This memo summarizes the changes reflected in the revised Data Dictionary and updated CACJ Data Collection Toolkit. It also includes reminders for quality assurance efforts.

Please remember these data will go into effect in FY 2026 Q1, after FY2025 Q4 reporting and maintenance window concludes. While it may be after July 1st for when some of these changes appear in the case management system, these expectations are in place for the FY2026 reporting window which opens October 1, 2025.

1) New list values for existing data fields

1. *Eligibility Denial Reason*
 - a. Participant Decline – Unable to reach
2. *Drug Test Comments*
 - a. Positive – Adulterated
 - b. Positive – Confirmed
3. *Risk Assessment Type*
 - a. YLS-CMI
4. *Termination Reason*
 - a. Housing instability
5. *Grant Type*
 - a. RED
 - i. This should be used only for BJA housing grantees
6. *Race*

- a. More than one race
- 7. *Additional evidence-based curricula*
 - a. Habilitation Empowerment Accountability Treatment (HEAT)
 - b. Grief Recovery Method
 - c. Helping Men Recover
 - d. MRT – Parenting and Family Values
 - e. Written Exposure Therapy
- 8. *Employment*
 - a. ‘Part-time more than 20 hours’ changed to ‘Part-time 20 hours or more’
- 9. *Income*
 - a. ‘Under \$999’ changed to ‘\$999 or lower’

2) **New validation rules**

- 10. Stable housing required when housing type or date reported
- 11. If a participant’s housing type is reported as Homeless/street, shelter, abandoned building, vacant unit, car, a full address is not required (only county).

3) **CACJ legal names**

- 12. All courts will now have a CACJ legal name. This legal name will be reflected on all official CACJ communication. Courts are welcome to use their preferred program name locally. See Appendix for complete list of FY26 CACJ-certified accountability courts (blue column reflect new legal name).

4) **Reminders for quarterly quality assurance checks**

- 1. Exit Dates
 - a. CACJ will ensure that each reported exiting participant includes both *Exit Date* and *Exit Status*. Courts should ensure all exits are reported for the quarter in which the exit occurs. Please refer to your preliminary QPR following the reporting period ending to verify. If any exits are not reflected, please contact CACJ before the maintenance window ends.
- 2. Acceptance Dates
 - a. CACJ will ensure that each reported active participant includes both an *Acceptance Date* and *Acceptance Type*.
- 3. Phase Movements
 - a. CACJ will ensure that each quarterly report includes information for each participant that was reported as active in the previous quarter.
 - b. Coordinators should update phase changes timely and at least within the quarter of the change. This includes but is not limited to program exit/separation (e.g., graduation, termination).
 - c. Participants who remain active phases for significant periods of time, or Inactive, will be flagged.
- 4. Employment and Income at Entry and Exit

- a. Courts should verify employment and income data is updated when a participant exits and reported within the quarter of that exit.
 - b. This data is very important for outcome analysis.
5. Diagnosis/Diagnostic Impression and Treatment
 - a. CACJ will ensure that each active participant has a reported *Diagnosis/Diagnostic Impression* and treatment sessions reported for that quarter.
 - b. CACJ has begun monitoring treatment dosage.
6. Drug Tests
 - a. CACJ will ensure that each positive drug test includes substance data and that each active participant has drug tests in each reporting period.
 - b. Additionally, CACJ will monitor drug test frequency against active participant counts.
 - c. Courts with and without drug lab integrations should ensure all drug testing data are submitted.
 - d. Courts with an integration should ensure external IDs are present for all participants.
 - e. Courts should update positive drug test results to ‘Approved – Positive’ for participants who are on MAT and change to ‘Negative’ when drug tests are confirmed negative.
 - f. If your court changes drug labs, please let your case management system vendor know immediately so they can coordinate a transition.
7. Treatment
 - a. CACJ will monitor treatment dosage through quarterly reporting.
 - b. Courts should ensure all treatment data are reported and submit any missing treatment data during the maintenance window.
8. CACJ will monitor continuity of reporting for all participants regardless of status, therefore coordinators must push every participant, every quarter even if no changes within the quarter occurred. Coordinators shall ensure all records are submitted successfully. Reporting should only occur during the designated window.

Coordinators and judges will be contacted by CACJ following the quarterly reporting deadline with questions and issues based on quality assurance checks. Coordinators must update records accordingly and resubmit during the determined maintenance window.
