TROUP COUNTY ACCOUNTABILITY COURTS

Eight years ago, Bill Dollar of Hogansville was approached by Clinton Hughes, the Pastor of Hogansville First Baptist Church, and asked to start their Celebrate Recovery program. "I really felt that God was speaking to me at that moment," said Bill, who, unbeknownst to himself, needed the recovery program as much as the people he would be serving. "I struggled with alcohol up until the day that I was asked to start Celebrate Recovery. I told Pastor Hughes that I was a drinker, and he told me that he had no idea, but that is the thing about addicts, we hide it well, don't we?" Shortly after starting the Celebrate Recovery Program, Bill was introduced to the Accountability Courts in Troup County. During his eight years with Celebrate Recovery, Bill has developed a relationship with the four Accountability Courts that operate within Troup County. "I've noticed that some of the Accountability Court participants that come to Celebrate Recovery aren't initially interested in what we are

teaching; they are just coming to satisfy a requirement. So many realize later on, however, that neither us nor the courts are trying to change them, we are trying to help them. I have heard so many court participants as they come up on their graduation date credit drug court for saving their lives, and I am able to see that myself. I am truly thankful to live in a County that treats someone that is suffering from an addiction as a person."

A few months ago, Bill was teaching one of his Life Lessons Bible Study classes and a thought was brought forward by the group: Why don't we put these lessons into a podcast? So that's what they did! Hogansville Baptist Church gave half of the funds needed to purchase the necessary equipment to start the podcast, and the Celebrate Recovery group raised the other half. Now every Sunday, for an hour after their usual recovery program, you can find a rotating cast of five men recording thoughts on some of the most intimate experiences of their lives and the lessons they learned from them, such as being in denial of their addiction and difficulties with past relationships. Gary Blanks is a 2020 graduate of the Felony Adult Drug Court and one of the reoccurring hosts. "Drug Court and Celebrate Recovery really showed me that I have a purpose in my life and that purpose is to help others," said

Blanks. "Recovery was something that I couldn't do alone, and even now I'm learning so much about myself."

Kevin Folds is another host and is currently an active participant in the Family Treatment Court. "There are a lot of people out there struggling with the same experiences that I have had in my life, and I want to try my best to spread a little hope." Seven months ago, Folds said he started thinking about what life will be like after graduating from the Family Treatment Court, and he knew that developing a sober network would be one of the best things he could do for himself. "I became more involved with Celebrate Recovery and came to the conclusion that I needed to do whatever it takes to stay on my recovery." Since staring the podcast, Folds



said he and the other hosts have developed a bond stronger than friendship and more like family. "If you don't have that good, strong, sober network, it is so much easier to fail," he said.



As of February 21, five episodes of the ARISE Ministry Podcast have been recorded and, according to Dollar, the average audience for each episode has been about 2,000 people.

"The whole point of this podcast is to reach those people that feel they are suffering in their addiction alone," said Blanks, "and let them know that they aren't alone. I haven't accomplished much in my life, but I feel that this is one of the best things I have ever done." In addition to Dollar, Blanks, and Folds, Wade Whitlock, another graduate of the Felony Drug Court, and Randy Brady fill out the cast of rotating hosts. LOOKOUT MOUNTAIN JUDICIAL CIRCUIT DRUG COURT

The Lookout Mountain Judicial Circuit Adult Felony Drug Court held its sixth graduation ceremony on January 7, 2021 with the Honorable Don Thompson presiding.

Additionally, one of the graduates was diagnosed with stage 4 cancer approximately three months prior to the graduation date. Her compromised immune system made attending in person too risky, so she joined via Zoom, as well. The Drug Court team delivered a cap and gown, along with her graduation certification, so she could participate fully with her graduating class.

Each graduate was given an opportunity to share personal highlights and special lessons learned. During their time of sharing, each graduate expressed thanks to those who impacted them over the last two years. One of the requirements for the graduate is to present their relapse prevention plan to the Drug Court team. Each graduate is also encouraged to highlight their plan during their presentation at the graduation ceremony, and all four of the graduates in this class chose to do so.

LASHEIKA KASSA TO SERVE AS DIRECTOR OF DEKALB COUNTY ACCOUNTABILITY COURTS

Lasheika Kassa was hired in January 2016 with the Council of Accountability Court Judges. She was one of the Council's first hiring decisions. She faithfully served as a certification officer, then as the first treatment fidelity program monitor, and prior to her departure, the treatment fidelity program manager. In her role as the treatment fidelity program manager, she provided direction to and oversight of the unique, evidence-based fidelity monitoring program, which she developed. She trained over 150 treatment professionals in the Cognitive Behavioral Interventions for Substance Users curriculum and provided various trainings to countless judges, coordinators, and accountability court team members. She was instrumental in assisting with conference planning and worked closely



with the Training Committee to help execute several trainings across the state. Ms. Kassa will now serve as the Director of Accountability Courts for DeKalb County.



Webinar: Mitigating Trauma in the Courthouse by Understanding Changes to the Brain

THURSDAY, MARCH 11 | 2:00 P.M. ET
