

VETERAN TREATMENT COURTS TRAININGS

The Council of Accountability Court Judges in partnership with Justice for Vets hosted a series of Veterans Treatment Court trainings during October. A two-day Veteran Mentor Bootcamp was held in Atlanta. A group of 52 Veteran Mentors received training and certificates during the event. Veterans Treatment Court enhancement trainings were also held in Marietta, Savannah, and Warner Robins. The enhancement trainings featured sessions on military culture, PTSD, veterans' affairs services, and more. Georgia currently has over 20 veteran treatment courts and several accountability courts provides services to veterans.
