LEVEL OF SERVICE CASE MANAGEMENT INSTRUMENT (LS/CMI) TRANSITION

Effective October 1, 2019, the Level of Service Case Management Inventory (LS/CMI) has replaced the Level of Service Inventory – Revised (LSI-R) assessment instrument. CACJ will no longer authorize LSI-R assessment use downloads.

All required courts have successfully completed the training requirements for the new assessment tool.

The CACJ website has been updated to provide helpful details for the new assessment. The revised webpage includes LS/CMI use requests, the LS/CMI assessment website (GEARS), a webinar to aid in administering the assessment, and the GEARS user help guide.



The 2019 Annual Training Conference was held September 15 – 18, 2019 in Athens, Georgia.

1300 attendees from Accountability Courts across the state met in Athens for the largest training conference to date! Over 40 breakout sessions and 3 plenaries featured speakers from the National Drug Court Institute (NDCI), Georgia School of Addiction Studies (GSAS), NPC Research, Center for Court Innovation, National Highway Traffic Safety Administration, American University (NHTSA), Prevention Research Institute (PRI), and Georgia's accountability courts and stakeholders. The conference also introduced a new feature, the mobile app.

Conference keynote speakers and special guests were Governor Brian P. Kemp and Mr. Terrence Walton, NDCI Chief Operating Officer. The Accountability Court Art Exhibit and Star Award Ceremony showcased participant talent and dedicated team members that make Georgia's accountability courts great! A new addition for the 2019 Training Conference agenda was the recognition of Georgia's Model Drug Courts.

LOWNDES COUNTY DUI COURT CELEBRATES NATIONAL RECOVERY MONTH

In 2019, the Substance Abuse and Mental Health Services Administration (SAMHSA) celebrates the 30th anniversary of National Recovery Month (Recovery Month), marking three decades of spreading the message that treatment is effective, and people can and do recover—every day. On September 13, 2019 the Lowndes County DUI Court held its 1st Annual Recovery Walk at the historic Lowndes County Courthouse in downtown Valdosta to raise awareness about addiction, promote behavioral wellness and show the community that recovery is possible.



Paige Dukes, County Clerk, kicked off the event by stating "Recovery Month reminds us that mental and substance-use disorders affect all of us and that we are all part of the solution.. She then introduced Laci Rankhorn, Owner of Redirect Counseling Services and treatment provider for the DUI Court, who addressed the crowd by stating that "recovery is different from person to person, but the essentials are always there and they are: health, home, purpose and community." She went on to explain how all four are an important part of daily living for recovery. Ms. Rankhorn concluded with an invitation to recite the Serenity Prayer.

Ellen Golden, Judge for Lowndes County State Court, who also presides over the Lowndes County DUI Court spoke about the history of the DUI Court and the mission and goals of the program. Since the DUI Court's inception in 2017, the Court has had 25 graduates successfully complete the strenuous program. The 26th graduate was recognized at the event. Ms. Dukes read the official Proclamation signed by Chairman Bill Slaughter and presented it to Judge Golden. Commissioner Joyce Evans was in attendance for the presentation of the proclamation. Families, activists and addiction survivors then walked in recognition of National Recovery Month around the historic courthouse with each other



with one thing in common – recovery. The Coordinator for the DUI Court, Stacey Bass, is hoping to make the walk an annual event to continue to raise awareness for recovery.

FULTON COUNTY BEHAVIORAL HEALTH TREATMENT COURT
